Coastline College is accredited by the Accrediting Commission for Community and Junior Colleges (ACCJC) of the Western Association of Schools and College.

Coastline's Paralegal Program has been approved by the American Bar Association since 1985. The American Bar Association approval (https://www.americanbar.org/groups/paralegals/approval-resources/general_approval_process_information/) process can be found in the ABA guidelines most recently published September 2021. Each ABA approved program must go through a re-approval every seven years. An interim report is due to the ABA every three years through that seven-year cycle. Coastline's most recent re-approval occurred in 2021. An interim report will be submitted for approval in 2024. The next cycle for Coastline's ABA re-approval will occur in 2027.
