## FINANCIAL AID

Financial aid programs help bridge the gap between the cost of education at Coastline College and the financial resources available to students from their families, employment, savings, and other sources. Eligible students can benefit from state and federal programs that offer fee waivers, grants, loans, and work-study opportunities.

## **Federal Financial Aid Requirements**

All recipients of federal financial aid must meet the requirements listed below:

- · In good academic standing
- · Be working toward an eligible degree or certificate
- · Have a high school diploma or GED
- · Be a U.S. citizen or eligible non-citizen
- · Have a valid Social Security number
- Have completed the Free Application for Federal Student Aid (FAFSA) or the California Dream Act Application (CADAA)

Note: Undocumented students are not eligible to apply for federal aid, but if determined to meet AB 540 requirements, they may be eligible to apply for state aid. See the California Dream Act website (https://dream.csac.ca.gov/).

# Academic Progress Standards California College Promise Grant (CCPG)

Students can lose their CCPG eligibility if they fail to meet the
academic or progress standards for two consecutive primary
terms (Fall & Spring). The academic or progress standards are
established by the California Community Colleges Chancellor's
