

ADMISSIONS INFORMATION

Admissions Eligibility

Golden West College welcomes individuals who can benefit from our instruction. Eligibility is determined by the following criteria:

- **General Admission:** Applicants 18 years of age or older are eligible for admission.
- **Admission for Under 18 Applicants:** Applicants under 18 may be eligible if they have:
 - Graduated from high school.
 - Obtained a California Certificate of Proficiency or GED.
 - Are currently enrolled in grades 9-12 and recommended for advanced academic or vocational college-level study (see "Dual Enrollment for High School Students" below).

Dual Enrollment for High School Students (Grades 9-12)

In accordance with California Education Code Sections 76001 and 76001.5, high school students in grades 9-12 may enroll in Golden West College courses for advanced academic or vocational study not offered at their high school. Enrollment is a collaborative decision between the high school and the college, based on the student's potential to succeed.

To enroll as a dual enrollment student, you must:

- Be actively enrolled in grades 9-12.
- Seek enrollment in a course that provides an advanced academic or vocational experience not available at your high school.
- Meet all prerequisite and co-requisite requirements for the desired course(s).
- Submit a completed "Dual Enrollment Form," signed by your parent/guardian and high school principal (or designee), recommending specific course(s) to the Admissions and Records Office or see details on our website: Dual & Concurrent Enrollment | Golden West College (<https://www.goldenwestcollege.edu/dualenrollment/>).

Adult Education Program Students

Students enrolled in an Adult Education Program (administered by a school district) or a noncredit program (administered by a Community College district) who are pursuing a high school diploma or equivalency certificate may be eligible for special part-time enrollment at Golden West College with the recommendation of their program administrator (as per SB-554).

Important Considerations:

Golden West College reserves the right to restrict enrollment based on factors such as health and safety, course appropriateness, student preparedness, college policy, state law, and space availability. Please note that enrollment in physical education courses may be restricted or excluded in accordance with SB338.

Special part-time students (9th-12th grade) may enroll in a maximum of 11.5 units per term (9 units max in summer term).

International students who are, or intend to be, under F-1 visa status should visit the website for entrance requirements at International

Student Program (<https://www.goldenwestcollege.edu/isp/future-students/>) Admissions (<https://www.goldenwestcollege.edu/isp/>). Students with B1 or B2 visa status are not eligible to enroll in a course of study, but may enroll into non-credit courses.

Application

New and returning students who have been absent for two or more primary semesters must submit a new application. Students are strongly encouraged to apply early in the application filing period in order to have time to complete all the requirements to be eligible for priority registration.
